I designate that 100% of the stallion service fee Stallion Owner agrees to contribute the purchase price of the stallion service to the activities of ECHF. East Coast Halter Futurity acts as a selling agent of the stallion owner and can in no way be held responsible for stallion and/or mare owners inability to get mare bred. Neither the East Coast Halter Futurity nor its Board of Directors shall intervene between the purchaser of the stallion service fee and the stallion owner. All contracts, arrangements and negotiations that arise in the service of any mare designated for the East Coast Halter Futurity will be strictly between the mare owner and the stallion owner. Stallion owner is responsible for listing all fees beyond normal breeding expenses at the time of the auction. Rules to this Futurity are an attachment to this agreement. Please read and keep for future reference.
